# THE LAND TRUST CONTINUES TO ROCK! \$75,000 Raised for the Footbridge in Three Months!

Just over three months ago, the Land Trust announced it would seek to raise \$75,000 to help pay for the much-needed footbridge at Bolsa Chica. Although the project was worthwhile, the Trust had never attempted anything like it and no one was sure it could be done. But now we know it can! On August 13, 2007, the Trust reached its goal of \$75,000. WE did it!

Under the guidance of our campaign co-chair, Carrie Thomas, the "Walk to the Wild Side" campaign started in May at our Town Hall meeting when seven year-old Madison Makoff delivered her birthday money to the Trust, the first of many significant donations. Then, after reading our last newsletter, **Chuck and Barbara Steel made an incredibly generous offer to the Trust. If the Trust could raise \$25,000 by the end of September, the Steels would match it with a \$25,000 donation.** We followed that up with

a brochure to our members and the response was overwhelming!

**One such response came from the family of Harold and Ellen Pazanti and Jayson and Rochelle Pazanti- Ruth. They donated \$5,000 to the campaign and took the goal over the top.** Jayson and Rochelle served on the Board of Directors while still in college. They created Bolsa Chica Bingo and were involved with the 1996 concert with Bonnie Raitt and Pierce Brosnan. Now, they have two children of their own, Jayden and Hudson, and live and work in Huntington Beach. Jayson teaches biology at Huntington Beach High School and Rochelle is Vice President of Pazanti Home Mortgage.

# DEVELOPER ATTACKS LAND TRUST IN LOCAL PRESS

In full-page color ads that appeared in the Huntington Beach Wave and Huntington Beach Independent newspapers, Shea Homes recently attacked the Land Trust for defending the Coastal Act.

“Look who won’t have to pay mandatory flood insurance -- if only the Bolsa Chica Land Trust would put your safety and pocket book ahead of their interests,” the ad stated. “Rebuilding the levees to bring greater flood safety could begin soon – but the Bolsa Chica Land Trust is standing in the way.”

How sad to see a major corporation stoop to attack a grassroots nonprofit with far fewer resources than they have. The Land Trust has NEVER been opposed to improving flood control. The Land Trust IS opposed to development that does not conform to the Coastal Act.

When asked by a reporter if Shea’s claims were true, an Orange County Flood Control District

spokesperson said Shea is overstating the case. Shea’s improvements alone would not be sufficient for adequate flood control, and the OCFC is also required to make improvements to the Wintersburg channel, which they are currently planning.

As so many of you know, the Land Trust is committed to the community. Our Bolsa Chica Stewards is a popular, long-term restoration program that has planted over 10,000 native plants at Bolsa Chica. Our Miracles of the Marsh education program brings 1,200 elementary school kids to Bolsa Chica each year to learn about the environment. The BCLT has fought – and won – on numerous occasions to protect the Coastal Act, the law of California. The Land Trust has even worked with a developer, Hearthside Homes, to acquire the lower bench of the Bolsa Chica Mesa and preserve it for eternity.

We believe Shea Homes’ resources could be put to better use by designing a project consistent with the Coastal Act, rather than attacking a volunteer community organization.

## MIRACLES OF THE MARSH COMPLETES ITS 5<sup>TH</sup> SEASON

The Bolsa Chica Land Trust has completed its fifth season of elementary school educational tours. Since the tours began in 2003, we have given 132 tours to more than 6600 school children. This year we had an exceptional team of 23 docents whose enthusiasm sparks the program. More than 30 schools have signed on for the BCLT tours, and the majority of the schools return year after year. Participating schools are as nearby as SeaCliff School which is in Bolsa Chica’s back yard, and as far away as Carson and Fullerton.

The Miracles tour program provides docent training. Linda Wolfe, our Education Coordinator, schedules the tours and docents, and sends study materials to the teacher and classroom. Bus funding is provided by the Land Trust. Each tour is set up to allow for small group learning, since there is a docent assigned for every fifteen students. Tour topics include Bolsa Chica history, wildlife, native plants, and water quality.

# PUBLIC HEARING A “NO GO” IN S.L.O. CCC Caves in to Shea’s Cry of “Unfair!”

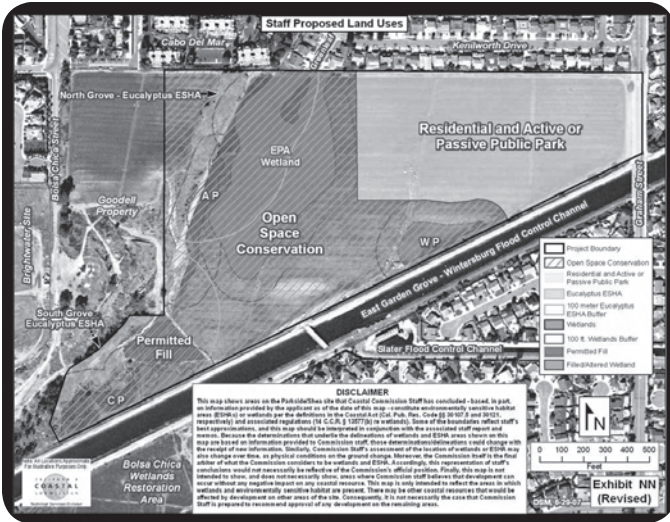


Exhibit NN from the June 29, 2007 CCC Staff Report caused Shea to postpone the hearing

the deadline of July 12 while complying with the Coastal Act.

However, Shea didn't want to follow the Coastal Act because doing so would require a public hearing on the LCP since it had been more than four years since such a hearing had been held. Shea wanted a delay, but not one that would require them to go back to the community for public input.

The Commissioners talked about “due process” and “fairness”, that the staff report came out during a holiday week, and certainly the City and Shea should have more time to digest the significant changes in the new report. So on a 9-3 vote, the Commissioners decided to simply grant a delay without following their legal counsel's advice, without following the Coastal Act.

On July 11, the California Coastal Commission postponed the public hearing on the City of Huntington Beach's LCP Amendment for the Shea/Parkside project until November. While a delay was not totally unexpected, the manner in which Commissioners granted the delay was highly disturbing.

While dismayed that the Commissioners chose to ignore the Coastal Act, and that many people traveled to San Luis Obispo in vain, the Land Trust is encouraged by the fact that with every delay Shea seems to lose more ground, both figuratively and literally.

Shea asked the City to request a delay due to insufficient time for them to review and respond to the latest CCC staff report and technical memorandums. The June 29, 2007 Staff Report states that a formerly unprotected area known as the “EPA wetland” should indeed be protected as a wetland. It further states that the unpermitted fills of dirt that the Land Trust illustrated at the May hearing in San Pedro were indeed improper fills. These changes reduced the residential footprint from 38 acres down to 17 acres.

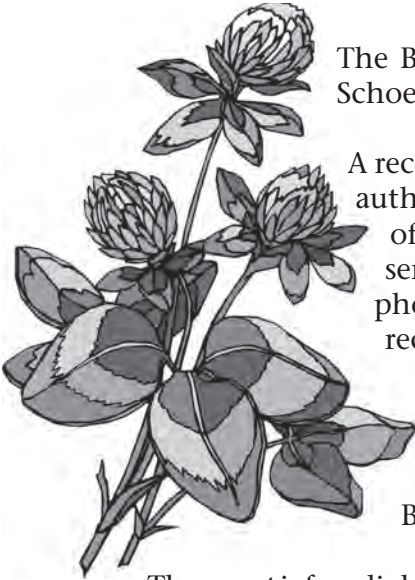
The next hearing on Shea/Parkside will be November 14-16 in San Diego. The Land Trust will once again be organizing transportation to the hearing. Please keep an eye on our website for the exact date and time.

The Coastal Act contains deadlines for the CCC to act on applications. Since the CCC took initial action on Shea/Parkside in May, denying the Land Use Plan as originally submitted, the CCC legal counsel explained the options for going beyond

## LAND TRUST RECEIVES BOEING GRANT

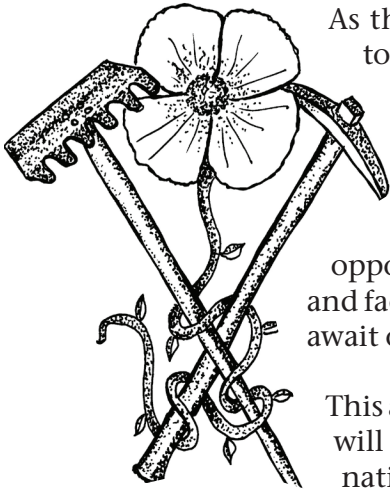
